# **Travel documents**

A valid Turkish passport can be used to travel from the UK to Turkey.

If you do not have a Turkish passport then an Emergency Travel Document (ETD) must be obtained if you wish to return to Turkey. To obtain an ETD you must submit a fully completed Bio-data form, four colour passport photographs, full UK birth certificate for any UK born children who will be removed with you. Any supporting evidence proving Turkish nationality such as an expired ID card, passport, NUFUS population identity card, NUFUS population certificate, Turkish driving license, family book, birth certificates or copies of such documents will be helpful. Supporting evidence must be translated into English.

# Return

If you are willing to return and want to ensure that you are returned to Turkey as soon as possible

- Contact your caseworker at the Home Office to say that you are willing to return;
- Make every effort to find supporting documentation for issuing of travel documents;
- Make contact with the Turkish Consulate to begin the process of obtaining a travel document.

You may find it useful to read the information below to begin preparing for your return.

# **Documentation in Turkey**

All Turkish citizens are legally required to have a national identity card (Nufus Kağıdı) To acquire a card you must present a birth certificate and proof of citizenship. The card contains every individual's Turkish Republic (TR) Identity Number, which is necessary for access to many public services.

If you do not have a birth certificate, a copy can be obtained from the Office of Vital Records in the municipality in which you were born. An application for a birth certificate can be made either in person or in writing by the individual concerned or his/her spouse, parents, children, grandparents, grandchildren, siblings, or authorised representatives. The applicant must submit:

- · document proving his/her identity;
- · a document which can prove that the records regarding birth concern the members of the applicant's family, or his/her siblings, or which proves that such records are necessary to exercise his/her rights in relation to state or self-governing authorities;
- · a notarised power of attorney if such application is submitted by an authorised representative.

## **Accommodation**

Lack of appropriate or affordable housing is a pressing issue in Turkey with many people living in informally rented accommodation or unauthorised settlements known as gecekondus. Assistance for the homeless is provided largely through charitable and faith-based organisations.



# Health

All residents in the Turkey must have health insurance. There are a number of private health insurance companies with whom you can register. For people in employment, the employer will pay for health insurance. For certain classes of people, insurance premiums are paid by the state

Once insured, to access services you must register with a GP who is registered with your health insurance provider.

Access to care is subsidised by the insurer but is still subject to payment of some fees except for immediately necessary emergency care.

# **Emergency support**

The social welfare system in Turkey is limited. Unemployment benefit is only payable to those who have paid insurance contributions through wages for (i) the last 120 days of their employment; and (ii) who have paid contributions for 600 days in the last 3 years. The programme is administered through the Employment Agency. For contact details see 'Employment, education and training' below.



Turkey provides free, compulsory eduction to children aged between 6 and 14. Secondary education is split into academic and technical streams. To progress to higher or further education in either a university or a technical college it is necessary to pass entrance exams and to pay fees.
