A valid Sri Lankan passport can be used to travel from the UK to Sri Lanka. If you have an expired Sri Lankan passport you can apply for a replacement.

If you do not have an original valid or expired passport an application will need to be made for an emergency travel document which consists of:

Submission letter to accompany ETD applications or further supporting evidence letter;

IS33 Form;

- · Bio-Data Form:
- Application form from the individual and the Home Office
- 4 passport photos
- · Supporting evidence, if available, to include original or copy of expired passport, original or copy of birth certificate, original or copy of driving licence, original or copy of ID card
- Full UK birth certificate must be provided for children born in the UK;

As part of the documentation process, a face to face interview with officials from the Sri Lanka High Commission is mandatory. Interviews can be conducted at the High Commission, HO reporting centres or immigration removal centres.

#### Return

If you are willing to return and want to ensure that you are returned to Sri Lanka as soon as possible you can:


- Contact your caseworker at the Home Office to say that you are willing to return;
- Make every effort to find supporting documentation for issuing of travel documents;
- · Make contact with the Sri Lankan Consulate to begin the process of obtaining a travel document.



You may find it useful to read the information below to begin preparing for your return.

# **Documentation in Sri Lanka**

The Sri Lankan National Identity Card (NIC) is compulsory for all citizens of Sri Lanka over the age of 16 and is required to obtain a passport, driving license and in order to be able to vote in elections. In order to apply you must complete an application form and provide your birth certificate as proof of age. For more information on how to apply see the Sri Lankan





There is no social housing in Sri Lanka. An individual returning to Sri Lanka will need to have money in order to rent accommodation or rely on relatives or friends.

#### Health

Sri Lanka provides free universal health care coverage to all its citizens. Private healthcare is also available. Both public and private healthcare facilities are readily available in all major towns and cities

# **Emergency support**

There is no state social security system for the unemployed, sick or elderly in Sri Lanka. Any emergency support comes from faith and charitable organisations.

# **Employment, education and training**

The education system in Sri Lanka is divided into five stages: primary, junior secondary, senior secondary, collegiate and tertiary. Primary education last 5-6 years, junior 4 years and senior secondary level lasts 2 years. Collegiate level lasts for 2 years during which time students take their GCE Advanced level examinations. Tertiary level education is provided through universities. Education in Sri Lanka is free and is compulsory between the ages of 5 and 15.

Vocational education and training in Sri Lanka is managed by the Tertiary and Vocational Education Commission of the Ministry of Vocational and Technical Training. Through its Vocational Training Authority, the Sri Lankan Ministry of Youth Affairs and Skills provides skills development programmes in a number of different subjects in training centres across the country. If you studied in the UK you may have certificates proving you have skills and qualifications which may help you to get a job. However, employers in Sri Lanka may not recognise these qualifications. If this is the case, you can contact the British Council who may be able to verify any qualifications issued by an accredited UK institution. You will need to provide the original document.
